1. BANKING LAW

- 1.1 Central Bank statement dd. 28.09.2010 explaining Central Bank decision not to change refinancing rate and fix it on its current level: 7,75% per annum.
- 1.2 Central Bank letter dd. 16.09.2010 No. 129-T "On increase in control over certain operations of legal entities" concerning submitting of documents on resident legal entities' operations transferring money in favour of non-resident counteragents to competent authorities.

6 BUREAU'S PRACTICE

6.1 Piksin & Partners Legal Services represented a famous foreign investor in the area of constructing compound production in criminal prosecution of a person charged of unlawful usage of trademarks and attempted commercial bribery to hide this fact. By the decision of Simonovsky district court of the city of Moscow dd. 20.07.2010 (case # 1-214/2010), the accused was found guilty in commitment of incriminated crimes and sentenced to 1 year and 6 months of imprisonment. Civil claims of damaged parties were accepted in full amount – 5'000'000 RUB.
