**News of the month:****1. STATE STRUCTURE**

- 1.1 The Budget Message of the President of the Russian Federation in Respect of Budget Policy in 2011-2013, which determines main goals and tasks of the economics policy and further prospects of national development.
- 1.2 Decree of the Government of the Russian Federation dated 15.05.2010 N 336 "On Amendments to Certain Acts of the Government of the Russian Federation", which grants to the Ministry of Economic Development of the Russian Federation the right to make a conclusion about the level of influence of a legal act on administrative regulation of entrepreneurial activity.

2. TAX LAW

- 2.1 Letter of the Federal Tax Service of the Russian Federation dated 10.06.2010 N ШС-37-3/3881 "On the Order of Calculating and Recording in Income Tax Declaration of the Income of Organizations, Received from Shares in Other Organization's Capital", concerning calculating of the mentioned tax, and rules of filling of the declaration.

3 ADMINISTRATIVE LAW

- 3.1 Decision of the Plenum of the Supreme Court of the Russian Federation dated 10.06.2010 N 13 "On the Amendments and Additions to Certain Decisions of the Plenum of the Supreme Court of the Russian Federation" which specifies the time period for considering of criminal, civil cases, and cases on administrative offences, as well as cases on challenging of legal acts, and clarifies the questions of application of the Code of Administrative offences of the Russian Federation.

4. CRIMINAL LAW

- 4.1 Decision of the Plenum of the Supreme Court of the Russian Federation dated 10.06.2010 N 12 "On Court Practice of Considering of Criminal Cases on Creation of Criminal Community (Criminal Organization) and Participating Therein", concerning the questions of application of criminal liability for creation of criminal community, participation as well as leadership therein or in its structure unit.
- 4.2 Decision of the Plenum of the Supreme Court of the Russian Federation dated 10.06.2010 N 15 "On Additions to the Decision of the Plenum of the Supreme Court of the Russian Federation dated 29.10.2010 N 22 "On Practice of Application by Courts of Measures of Restraint as Custodial Detention, Bail, House Arrest", which specifies the grounds for judicial application of such measures in respect of persons, who committed a crime in the sphere of entrepreneurial activity.

- 5.1 Federal Law dated 28.06.2010 N 123-Φ3 “On Amendments to the Article 1 of the Federal Law “On Personal Data” and Article 15 of the Federal Law “On Ensuring Access to the Information about the Activities of Courts in the Russian Federation”, which specifies the issues concerning information about courts activities, and rules of official publication of the acts, passed by the courts of general jurisdiction.
