#### 1. TAX LAW

1.1 Joint Letter of Tax Department and Pension Fund dated 11.08.2010 No. ЯК-17-8/58/АД-30-24/8509 "On amendments to Federal Law "On reimbursement of excessively paid (collected) insurance fees for obligatory pension insurance, fines, and penalties" which clarifies the procedure of reimbursement of excessively paid (collected) insurance fees for obligatory pension insurance, fines, and penalties put to the budget of Pension Fund for the periods of 2002-2009.

#### 2. ADMINISTRATIVE LAW

- 2.1 Letter of Federal Service on supervision in the area of consumers' rights protection and people's welfare dated 11.08.2010 No. 01/11739-0-32 "On amendments to the Code of Administrative Offences of the Russian Federation" related to the questions of calling to account of public officers of federal executive state bodies for breach of legislation on state control.
- 2.2 Order of Prosecutor General's Office of the Russian Federation dated 11.08.2010 No.313 "On procedure of forming by the prosecutors' offices of annual consolidated plan of legal entities and individual entrepreneurs inspections" which states the terms and procedure of forming the inspection plan.

3.1 Decision of Judicial Committee on civil cases of the Supreme Court of the Russian Federation dated 23.08.2010 No. 75-B10-2 which clarifies questions related to salary accounting relative to the rate of salary and lower limit size of remuneration of labour.

4.1 Order of the Chamber of trade and commerce of the Russian Federation dated 27.08.2010 No. 39 "On Rules of impartiality and independence of arbitrators" which clarifies certain questions of arbitrators' activity and fixes the procedure of their rejection and disqualification.
